# Scotland Talks Data Public Panel

## **Making a Difference**

**Impact report 2024** 







### What is the public panel?

The Scotland Talks Data panel is jointly hosted by the <u>Scottish Centre for Administrative Data Research</u> (SCADR) and <u>Research Data Scotland</u> (RDS). The panel discusses a range of topics from data systems to research projects, which helps to inform research and the use of administrative data research in Scotland. The panel includes members of the public from diverse backgrounds across Scotland.

#### What impact has the panel had?

The panel members have helped researchers and partners better understand public viewpoints on the use of administrative data for research.

The panel has provided feedback on a range of research projects, informing:

- Language used;
- Dissemination plans;
- Groups or organisations who could be involved; and
- Future ideas for research that matters.

#### Take a look at some of our highlights from 2024:

#### Synthetic data

Panel feedback has informed <u>synthetic data approaches</u> and processes after it was shared at a UK-wide meeting on public engagement with synthetic data, which included ADR UK (Administrative Data Research UK) and NHS England. This feedback:

- Influenced ADR UK's call for a larger project to gather insights from the public on the use of synthetic data. Funding was awarded to Cardiff University, with results to be published in Spring 2025.
- Directly informed how Research Data Scotland creates and allows access to synthetic data.

#### **Research Data Scotland video explainers**

Members of the panel provided feedback on three HDR UK (Health Data Research UK) funded video explainers about data.

The feedback on phrasing, pace and visuals shaped the final <u>three videos</u> <u>produced</u>. The Synthetic Data <u>video</u> was subsequently used in public

dialogue sessions as part of the ADR UK-funded 'Discussing Data' project at Cardiff University, and the videos won the silver prize for 'Best Use of Animation' at the DataComms Awards 2025.

#### **Researcher Access Service and private sector access**

Research Data Scotland's Researcher Access Service and draft policy for private sector access to public data were reviewed by the panel. The panel were also informed about a plan to hold larger public engagement workshops on their development.

The panel approved the themes in development for the workshops, though asked for clarity on some private sector models for collaboration, which have been rewritten. The panel also asked to be involved in further development, therefore two members were invited to join a steering group.

#### **Public Engagement Fund**

Two Scotland Talks Data panel members joined a funding panel to review applications to Research Data Scotland's <u>Public Engagement Fund</u>. They helped to review the applications along with five public engagement, data, and community professionals. Their input and feedback led to five projects being funded, which will engage with a range of audiences across Scotland.

#### **COVID** research projects

Two pieces of research the panel provided feedback on appeared in <a href="Covid-19">Covid-19 inquiries</a> in 2024, providing vital evidence and understanding of

the pandemic and helping to shape recommendations for the future. In 2024, the panel reiterated that this is still an important topic to help future pandemic planning.

#### **Brain Health Data Pilot and SCANDAN**

In April 2024, two studies were presented to the panel—one looking to permanently link brain scan information and the other aiming to develop AI to understand dementia risk. Feedback suggested caution over commercialisation of the projects and the need to develop the communication. The feedback was taken onboard and panel members invited to a further optional meeting to review changes based on feedback. Their feedback led to an update to an explainer video, the development of an FAQ informed by panel queries and the continued inclusion of the public throughout the project.

#### Households and Unique Property Reference Numbers (UPRN)

In 2023, the panel provided feedback on an infographic about how linked datasets and household analysis can improve our communities. The feedback was taken on board and the infographic published in 2024.

- Safe Haven Federated Governance
- Being named on funding bids
